

DOMESTIC EXHIBITORS WITHOUT DISTRIBUTION IN FLORIDA

DEADLINE FOR RECEIPT OF ALCOHOL IN WHOLESALER'S WAREHOUSE IS MARCH 1, 2019

If your alcohol beverage is produced or warehoused in the United States, but not distributed in Florida you may choose to work with either of the two WSWA Florida wholesalers listed in the WSWA Alcohol Beverage Product Handling Guidelines.

Please follow the steps below:

1. Read and follow the instructions in the WSWA Alcohol Beverage Product Handling Guidelines.
2. Complete all necessary forms by the deadline.
3. Pay all taxes and fees to the selected wholesaler.
4. Prepare your shipment using crush resistant packaging. WSWA, wholesalers and Shepard are not responsible for breakage.
5. Affix the appropriate destination labels on the SIDE of each case before shipping. Destination labels can be found in the Important Links section to the right.
6. Ship your products to the intended wholesaler. The wholesaler will arrange delivery to the hotel and to Shepard.
7. Complete the Alcohol Beverage Product List. This list will be used to inventory and sort your shipment once it arrives in Orlando.
